Second Reading of the Resolution for funding a Mural Project at Municipal Hall: On January 20, 2016, Bandera Economic Development Corporation (EDC) voted unanimously to approve a funding request for commissioning and installation of mural depicting cattle crossing the Medina River. This mural is relevant to Bandera's history because our city was the "gathering" point for ranchers to herd their cattle to Kansas. The mural will be on the end of Municipal Hall facing Heritage Park. The request is for \$12,700.00 for art commissioning (including materials) and installation. There will be no financial impact to the City of Bandera for this project. The project will be a positive tourist impact and will enhance our brand ... Cowboy Capital of the World.
